

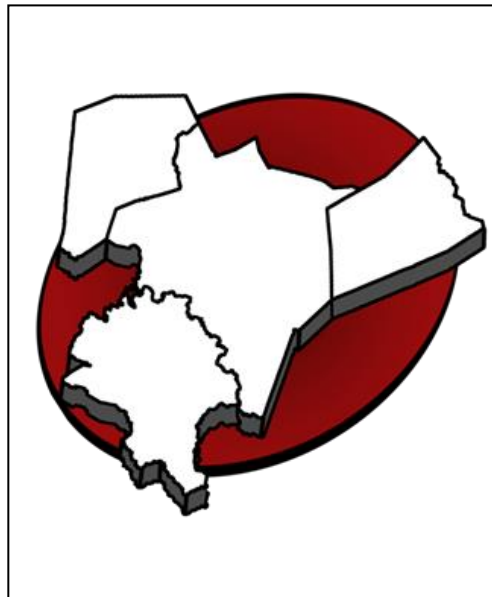

## **History and Mission of the Regional Intergovernmental Council**

The Boone-Clay-Kanawha-Putnam Regional Intergovernmental Council (RIC) was established in 1970 as a voluntary association of local governments. In 1971, it was designated by then Governor Arch Moore as West Virginia Region III, one of eleven such councils in West Virginia. RIC is committed to promoting economic, environmental, educational, cultural and recreational growth in Boone, Clay, Kanawha and Putnam Counties.

In 1975, RIC was designated as the Metropolitan Planning Organization (MPO) for the Charleston Urbanized Area. Later, this was expanded to include the entire Metropolitan Area (Kanawha and Putnam counties), to match the air quality non-attainment area. All urbanized areas in the U.S., as a condition of receiving federal highway and transit funding, must have an official MPO, whose responsibility it is to carry out a coordinated, cooperative and comprehensive planning process. This includes development of various transportation plans and programs in cooperation with state and local officials, transit agencies and local citizens.

RIC's policy board is comprised primarily of representatives of 25 municipal and four county governments in the Region. The board acts as a forum for discussing mutual problems and dealing with issues that transcend political boundaries. The RIC staff works for all 29 units of government by assisting with multijurisdictional issues.

The general purpose of the Council as stated in its by-laws is as follows:

“The Council is organized and shall be operated as a cooperative organization of local governments for the promotion of public health, safety and welfare by providing improved public services and facilities, advancing the business prosperity and economic welfare and achieving a satisfactory level of living for the citizens of the area served by the Council.”
