Scope and Purpose

Scope: The listing includes all federally funded surface transportation projects authorized, revised to increase obligations for, requested, obligated, and remaining in the Transportation Improvement Plan (TIP) for the State Fiscal Year 2021 that ends on June 30th, 2021. Some projects listed outside of this deadline remain for informational purposes. The projects on the list are those within the urbanized area known as the Charleston Metropolitan Area that is contained within Kanawha and Putnam counties geographically. The list includes all transportation projects including pedestrian walkways, bicycle transportation facilities, a listing of transit capital improvement projects and grant awards. Details on the requirements guiding the scope of this list can be found in the Code of Federal Regulations Title 23 Chapter I Section 450.334.

Purpose: The Regional Intergovernmental Council (RIC) serves Kanawha and Putnam counties as the Metropolitan Planning Organization (MPO) responsible for transportation planning. The Charleston Metropolitan Area is defined as an urbanized area containing a population of more than 50,000, as determined by the Bureau of the Census. As a result, annual production of this list is required by law. The list provides local citizens and government officials with transparency as to how federal transit and highway dollars are being spent in their neighborhood in a clear and concise manner. Additional details regarding these definitions can be found under United States Code Title 49 Section 5303.

Note: Obligated projects are not always completed in the programmed year. The amount of obligation oftentimes does not equal the total cost of the project.
