Communications Equipment, FY 2022 - FY 2025, Section 5307 &/or Other*** funds to be used for the replacement and or expansion of the Authority's existing communications equipment systems both on authority vehicles and in our facilities; included but not limited to radios, modems, routers, etc., and other communications devices to improve efficiencies and passenger amenities. **KVRTA has programmed the replacement of Radios for FY 2024**
